The purpose of this letter is to announce that the California Department of Public Health, California Tobacco Control Program (CDPH/CTCP) has revised RFA CG #22-10403, *Empowering Local Communities to End the Tobacco Epidemic*. 2. Updated RFA CG #22-10403, Page 7, PART II. KEY ACTION DATES AND RESOURCES, A. TIMELINE AND AWARD SCHEDULE, **Table 2. Tentative RFA Timeline and Award Schedule**, Mandatory Letter of Intent Due: The Date column has been updated from October 20, 2022, 5:00 pm, to October 28, 2022, 5:00 pm.
3. Clarified RFA CG #22-10403, Page 20, PART III. COMPLETING THE OTIS APPLICATION, C. SCOPE OF WORK: INTERVENTION AND EVALUATION PLAN (10 POINTS), 3. Two Objective Minimum Requirement, B. (Required) Policy Objective. Applicants must include both Indicators 2.2.35 and 2.2.13 for Option A.
4. Updated Appendix 1: County-Level Smoking Disparities Among Priority Populations. Definition and formula updates made on Page 1 and 3. Corrections made to the non-LGB column in Table 1 on Pages 6-7 and Table 2 on Pages 9-12, as well as the LGB column in Table 3 on Pages 13-14.
